Subject: Deputy Chair and Assistant Deputy Chair – elections

1.0 Purpose of the Report

- 1.1 Following Norbert Lieckfeldt's appointment as Corporate Governance Manager within the ELFT Membership Office, there is a vacancy for the Deputy Chair role.
- 1.2 There is also a vacancy for the Assistant Deputy Chair role.

2.0 Nominations Process

- 2.1 The Council discussed and agreed a process at their last meeting in March 2018. Following this meeting, the Membership Office sent an email on behalf of Georgia Denegri with the nomination forms and deadlines for nominations.
- 2.2 The deadline was first extended to 27 April 2018 due to a mistake with the dates. However on 27 April 2018, it became apparent that these details had not been received by all Governors and so the deadline was extended to 4 May 2018 to check that all Governors had received the nomination information.

3.0 Election Process

3.1 At the start of the meeting, each Governor will be given two ballot forms (Deputy Chair and Assistant Deputy Chair) in a Freepost envelope. The ballot papers will be numbered individually, but the Membership Office will not know which Governor has received which ballot paper to maintain the anonymity of the process.

- 3.2 Governors who are not recorded as having received ballot papers at the meeting will be sent the ballot papers and a Freepost envelope the following day.
- 3.3 Each candidate has prepared a statement to support their nomination (attached to this report), and they will have the opportunity to address the Council meeting on 17 May 2017 for three minutes only.
- 3.4 Each Governor has one vote for the Deputy Chair and one vote for the Assistant Deputy Chair, and will cast their vote by a cross (X) next to their preferred candidate. Please be exact: if the intention is not clear, the vote cannot be counted.
- 3.5 The Governors can vote and return their papers in the sealed envelope to the Membership Office staff at the meeting, by the Freepost envelope by Thursday, 31 May 2018 or by manually handing them to the Membership Office at Trust HQ. Any votes received after this date will be invalid and will not be counted.
- 3.6 The valid votes received will be counted on Friday, 1 June 2018, by the Membership Office staff, and the results advised to the successful candidates and the Trust Chair, the unsuccessful candidates and then the wider Council. The papers will be kept in the Membership Office and will be available to any Governor who wishes to see them.
- 3.7 In the event of a tie for the Deputy Chair role, the two candidates will be asked to come to meet Marie Gabriel and the successful candidate will be decided by a drawing of lots.
- 3.8 In the event of a tie for the Assistant Deputy Chair role, this will be decided at the July 2018 Council of Governors' meeting by the drawing of lots.
- 3.9 The appointments will be confirmed by the Council at their meeting on 19 July 2018.

4.0 Action requested

- 4.1 The Governors are asked to vote for the Deputy Chair and Assistant Deputy Chair and return their ballot papers to the Membership Office staff either during this meeting or via the Freepost envelop provided.
- 4.2 The Governors are asked to note that the closing date for voting is Thursday, 31 May 2018: any votes received after this date will not be counted.
