JOB SUMMARY

The VDI Engineering Specialist is a key member of the VDI Engineering team. The post is responsible for operational maintenance of the Trusts VDI infrastructure, the associated software, management and support. The role utilises expert knowledge to act as a point of escalation and co-ordinates or schedules junior staff within the team.

The post-holder is responsible for monitoring and maintaining the ongoing operation of the Trust's VDI platform & associated endpoints, making optimal use of management tools to proactively manage any issues that may interrupt service. The role incorporates customer care, vendor or relationship management, operations and communications co-ordination. Responsibilities include: -

- Utilise expert knowledge to resolve a range of varied, complex technical issues and explain complex situations in simple terms to staff at all levels
- Respond to technical enquiries regarding the appropriate purchasing, disposal, and
 effective use of the Trusts VDI platform and associated endpoints from all departments in
 accordance with Trust policies and procedures
- Escalate any recurring problems which users are experiencing, so that a more comprehensive and effective solution can be applied
- Provide expert support or guidance relating to VDI associated service requests, problems or issues
- Liaise with 3rd party vendors as required, ensuring that sufficient technical information is provided for each call logged
- Ensure that VDI Engineering associated documentation is maintained and updated
- Manage and prioritise ongoing maintenance of the Trust's VDI platform to ensure fitness for purpose is sustained
- Management and design of solutions associated with the VDI platform and associated endpoints, thin clients, user profiles and machine or user policies.
- Work with the VDI senior specialist and VDI Engineering manager focusing on quality or continual service improvement

The post holder is also responsible for working closely with the project teams, ensuring VDI Engineering team tasks are identified, planned and executed effectively. This involves working as part of a team or on an individual basis with 3rd party vendors, internal or external stakeholders and other technical experts, ensuring assigned project tasks are completed within project tolerances.
