
- Question 1: Who is the head of procurement responsible for approving agency usage for Sterile Services at East London NHS Foundation Trust?
- Question 2: Who is responsible for agency usage (on and off framework) in the Sterile Services/Decontamination department at all hospitals associated with the Trust?
- Question 3: Please can you provide the contact number and email address for the manager(s) in questions 1 and 2.
- Question 4: Have you used off-framework agency staff between March 2021 March 2022 in Sterile Services?
- Question 5: How much was your Off-Framework agency spend for Sterile Services between August 2021 and August 2022?
- Question 6: Do you currently outsource your Sterile Services/Decontamination department, if yes, who do you outsource it to?
- Answer: The Trust has reviewed questions 1-6 of your request for information under the Freedom of Information Act (FOI) 2000.

Section 1(1) of the Freedom of Information Act 2000 states:

Any person making a request for information to a public authority is entitled—
