Rio: Enhanced Gender, Sex, Pronouns and Sexuality Demographics

In October 2022 ELFT Rio has been updated to enable the capture of diverse gender
pronoun and sexual orientation demographics for ALL patients. These amendments are in
line with the NHS Data Dictionary and ELFT's values as an inclusive organisation.
There has been a new alert created to support confidentiality of diverse demographics, this is particularly important for gender diverse young people who aren't out in certain settings i.e. family or school.
These demographics are available for all patient's on ELFT Rio MH and CH
All individuals identify with a gender, have pronouns and sexual orientation as such future registrations on Rio will use these enhanced demographic options, PLUS existing patients should be offered the opportunity for their demographics to be updated via business support or clinical staff.
By utilising the same demographics for ALL patients regardless of identity, it will enable us to monitor the number of different identities and their associated outcomes to ensure there is equity of access and address any inequalities experienced.

Existing gender demographics

- The existing demographics are limited and do not reflect the array of identities adopted by individuals we care for
- Moving forward for new patients, these gender options will not be utilised as the primary options.

• Spine Linked Gender

- The Spine Linked Gender cannot be amended and is related to a person's legal gender, this is only changed with the issue of a new NHS Number and will be rare for children and young people
- o How To Change Your Gender Marker With Your GP

• Options from the picklist

- Staff will have predetermined picklist plus "Self Described", "Do Not Know" and "Do not Wish to Share"
- Please use "Self Described", when a patient's identity does not match the drop down picklist and enter the identity they have written in free text
- Please use "Do not Wish to Share" when a patient overtly declines to share
- o Please use "Do Not Know" when a patient leaves options blank

Improving the quality of protected characteristics and other vulnerable groups data in the MHSDS




Key principles on how to collect this data:

- Always enable patients to self-report information about their identities and life circumstances.
- Never make assumptions in the questions patients are asked about their identity and circumstances, and the data that is recorded.
- Embed these ways of working across all staff roles, service design and processes to provide trauma-informed care that makes patients feel safe and empowered to share personal information.
- Routinely use and feedback the data collected to ensure that everyone working in mental health, learning disability and autism services in is clear on the value of it and using it to advance equality.
- Patients are under no obligation to disclose anything that they are uncomfortable with and reassure them that if they choose to disclose this information, it will be kept confidential.
- If a patient wishes to know why you are asking for this data, you can inform them that the service collects this information so that they can appropriately provide for all their patients and ensure that it is inclusive of people of all identities.

3. NHS spine linked gender field

a.

- a. The spine linked gender will remain unedited and will only be changed with the issue of a new NHS Number via the GP, this will be rare for children and young people
- b. How To Change Your Gender Marker With Your GP

4. How Do You Describe Your Gender?

- a. "A person's innate sense of their own gender, whether male, female or something else (see non-binary below), which may or may not correspond to the sex assigned at birth."
- b. If an individual identifies as trans female, they would select female and No their gender does not align with their sex assigned at birth to indicate gender diversity

5. Does your gender align with the sex you were assigned at Birth?

a. "We are all assigned a sex at birth (in the UK, babies have to be registered as male or female) but our gender identity is our internal sense of our gender (male, female, non-binary, or something else). Most patients gender will align with their sex assigned at birth i.e. they were assigned male and identify as male"



6. What pronouns do you use?

a. "Words we use to refer to people's gender in conversation - for example, 'he' or 'she'. Some people may prefer others to refer to them in gender neutral language and use pronouns such as they/their."

- a. "A person's sexual attraction to other people, or lack thereof. Along with romantic orientation, this forms a person's orientation identity"
- b. Although Rio utilises "Other" please utilise "Self-Describe" on referral forms





8. Confidentiality


- a. It is important to record details of who the patient is out to, this will reduce the risk of Outing them "Outing is when a lesbian, gay, bi or trans person's sexual orientation or gender identity is disclosed to someone else without their consent."
- b. Example text might include:

 Patient is out to peers and staff at school but not to their family, please use their birth assigned demographics in session with family or on any letters, emails, texts
- c. Note: Local processes will be required to ensure alerts are referred to routinely for both clinical and admin functions





9. Name, Alias

- a. As young people explore their identity their name may also change, sometimes more than once
- b. Any additional names entered in Rio will not update the NHS Spine
- c. For their name to show under their spine registered name, we must use the "Preferred Name" although young people have fed back, they do not like to use this phrase and should be titled differently on referral forms.
