Question 1: What communication have you received from NHSI and NHSE in regards to moving locum agency doctors on to hospital bank between August 2022 & August 2023?

Answer: The Trust has received communication on utilising the NHS professionals national bank, for the conversion of agency staff to bank.

Question 2: What additional communication has your trust received in the year 2024 in regards to moving doctors from agency on to bank?

Answer: The Trust has also received communications on routine engagement with LPP and Cavendish Square Group.

Question 3: What, (in both percentage and nominal terms) of your temporary doctor staffing spend went on bank in the last 12 months? Please provide figures for the 12 months previous for comparison.


