optic internet. The Trust's internet service is via a hosting provider at our data

centre sites (Managed Internet Access /Dedicated Internet Access

connection).

The Trust has a National PSTN Switch-Off project which is scheduled to replace all of these within the next 18 months. Spread across these scheduled works are site-by-site full audits, to obtain full details on each site's telephony.

Therefore, the Trust is unable to provide these details outside of that project.


