## Request:

The particular information I would like is related to the DECARHUB and in particular the policies and procedures regarding missed appointments and non-engagement of patients under the ADHD clinic.

Clarification: In all questions I am specifically referring to the DECARHUB, and not the Trust as a whole.

I would like to know how many missed appointments will result in a patient being discharged and what methods of communication will be attempted before the discharge is processed.

Further to this I would also like to ask about the current waiting list for an ADHD referral. I was most recently told that it would be around 6 years and I would like to ask if this is correct and how many people are on it. To summarise this, the information I would like is:

Clarification: In all questions I am specifically referring to the DECARHUB, and not the Trust as a whole.

#### Question 1: How many appointments must a patient miss to be discharged from the

**DECARHUB** due to non-engagement?

Answer: Two missed appointments will result in the patient being discharged; however, this will be determined on an individual case by case basis.

### Question 2: How many times should contact with the patient be attempted before discharge?

Generally, the Trust will attempt to contact the patient twice before discharging Answer: them, however, this will be determined on an individual case by case basis.

### Question 3: How long would someone referred to for an ADHD assessment today be expected to wait for a first appointment?

Clarification: I am specifically asking about the number of people who undergo an ADHD assessment under the DECARHUB per month.

Answer: Currently, the wait time for a first appointment for an ADHD assessment under the DECARHUB is six years.

#### Question 4: How many people are currently on the waiting list for an ADHD assessment?


