## Request:

Thanks for sharing the link to the Judiciary website. However, this response does not provide access to the information that is being requested due to the following reasons:

- 1. The Judiciary website contains coroners' Prevention of Future Deaths reports (PFDs) that have been sent by local coroners or coroners' offices to the Chief Coroner's Office for publication. It, therefore, does not contain all PFDs that East London NHS Foundation Trust has directly received from coroners as requested.
- 2. The search function on the Judiciary website is not sophisticated enough to account for the spelling errors and inconsistencies in reporting recipients' names that result from the manual writing and publication of reports.
- 3. To identify PFDs where East London NHS Foundation Trust is listed as an 'interested person' within the document, these are only 'searchable' on the Judiciary website from January 2023 onwards when the Chief Coroner's Office started publishing the full text of reports online. Therefore, the request for the total number of PFDs where East London NHS Foundation Trust was copied for information as an 'interested person' is not accessible from the link shared.
- Question 1: The initial request did not seek copies of each PFD received; rather, it requested a summarised annual count of the total number of PFDs that East London NHS Foundation Trust has directly received as a listed addressee and copied for information as an interested person.

Could I please request this information from 2015 until May 2024 (or the most recent data available), broken down as annual counts for each calendar year?


