

East London NHS Foundation Trust does not centrally record the information requested. While we centrally record requester categories (data subject, 3rd party, etc.), the figures we receive from directorates/services that manage their own requests aren't broken down to reflect whether they are from patients. Furthermore, in the years preceding 2023/2024, there was a different categorisation method in use which used details and sometimes names of requesters. Therefore, the Trust is therefore unable to provide a response.






