Request: In your Provider Collaborative area:

Question 1a: How many CAMHS Tier 4 beds are commissioned? Please give figures for each year from 2020 - 2024.

Answer:

The North Central and East London (NCEL) CAMHS Provider Collaborative has reviewed question 1a of your request for information under the Freedom of Information Act (FOI) 2000.

Section 1(1) of the Freedom of Information Act 2000 states:

Any person making a request for information to a public authority is entitled— (a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and

(b) if that is the case, to have that information communicated to them.

The NCEL Provider Collaborative does not record the information requested in this format. However, the information is recorded in Occupied Bed Days (OBDs).

The NCEL CAMHS Provider Collaborative was launched in October 2020. where the CAMHS Inpatient commissioning responsibility was transferred from NHS Specialised Commissioning Team to NCEL CAMHS Provider Collaborative.

NCEL inherited the commissioning approach from NHS Specialised Commissioning Team. Therefore, instead of commissioning CAMHS Inpatient based on numbers of beds, OBDs are used. Please see the figures below:

Coborn Centre GAU: 3,225 OBDs

Coborn Centre PICU: 3,954 OBDs

Beacon Centre GAU: 4,121 OBDs

Brookside GAU: 4,770 OBDs

Simmons House GAU: 3,831 OBDS

Answer: Number of informal admissions from the NCEL CAMHS Provider Collaborative to Tier 4 beds:

2024: 66 informal admissions to date (23/08/2024)



The NCEL CAMHS Provider Collaborative does not record the information requested and is therefore unable to provide a response.


#### **Access Assessments:**

Question 2: We understand that access to CAMHS Tier 4 inpatient services is by way of an Access Assessment. Please provide details of the policy and procedure for carrying out CAMHS Tier 4 access assessments, together with any further documents pertaining to Access Assessments.

Answer

All NCEL CAMHS Provider Collaborative referrals for CAMHS Inpatient beds are made directly to the Patient Flow Team (PFT) using a Form 1, which is a national referral form.

### Identifying Need for Tier 4 In-patient Beds/ Access and Assessment protocol

In line with recommended practice, the bed management team will work with community CAMHS teams to review and agree the most appropriate level of care.

Following Assessment and Risk Assessment by a community CAMHS team, should a tier 4 placement be identified as possibly required, the clinical with the bed management team will liaise with clinicians in the Young Person's local CAMHs crisis/inpatient pathway to determine the most appropriate care pathway. Depending on locality this may include consultation with:

- NCL Nurse Out of Hour Service & HTT
- NELFT Interact Team
- Home Treatment Teams (HTT) & ELFT ICCS: the HTT & ICCS will screen the case to consider
  whether they are able to provide intervention to keep the CYP at home and avoid admission.
  If they are unable to offer a place within the HTT/ICCS, the bed management team will be
  notified and will commence bed finding.
- Borough based CAMHS Crisis Teams, Adolescent MH Teams and AOT teams where they
  exist.

If the Young Person has Autistic Spectrum Disorder and/or Learning Disability a Community Emergency Treatment Review (CETR) should be arranged by the referring clinician prior to admission wherever possible. The exception is when an emergency admission is required which cannot safely be delayed for the CETR. If the admission is deemed urgent and necessary, then a LAEP (Local Area Emergency Protocol) should be carried out before any admission to Tier 4 services.

Referral for Tier 4 admission should only be considered when:

- All community services and options have been ruled unsuitable and there is no viable alternative within the local provision of care.
- Inpatient care, or intensive community treatment is the least restrictive, effective and safe option available to manage the clinical situation

# Question 3: Is there currently a waitlist for Access Assessments and if so, how many people are on the wait list in your Provider Collaborative area?

Answer The NCEL CAMHS Provider Collaborative does not have such a waiting list for access assessments.

Question 4: Have any Mental Health Act assessments, where it has been determined that the child needs compulsory detention, been overridden by access assessments in your Provider Collaborative?

Please give figures for each year from 2020 – 2024.

The NCEL CAMHS Provider Collaborative Mental Health Act assessment information was only collected for 2023 onwards. This is when NCEL as a collaborative made the decision to expand their local database to incorporate MHA status, which enable NCEL to audit this information. There have been such cases.
