- Request: Under the Freedom of Information Act 2000, I request the following information for the past year 2023/24 concerning the East London NHS Foundation Trust's Child and Adolescent Mental Health Services (CAMHS)
- Question 1: The average and maximum waiting times for routine treatment with CAMHS Eating Disorder Services
- Answer: Average waiting time for routine treatment: 35 days.

Maximum waiting time for routine treatment: 244 days.

Please note: CYP Eating disorder services started back April 2016, the clock stopping definition was second face to face contact. During the Covid pandemic, our clinics started to offer virtual assessment via video link and NHSE agreed that the clock could be stopped at second direct contact (face to face/video). On 3 December 2021 NHSE issued updated clock stopping guidelines, the updated clock stop definition is first direct contact with SNOMED codes. The data provided is based on the clock stopping at second face to face contact definition.

# Question 2: The average and maximum waiting times for urgent treatment with CAMHS Eating Disorder Services

Answer: Average waiting time for urgent treatment: 11 days.

Maximum waiting time for urgent treatment: 30 days. (Data quality issues) and referral received during the Covid period.

During the Covid pandemic, our clinics started to offer virtual assessment via video link and NHSE agreed that the clock could be stopped at second direct contact (face to face/video). The data provided is based on the clock stopping at second face to face contact definition.

Answer: 226 patients waited 0-4 weeks for treatment.

- Answer: 38 patients waited 4-8 weeks for treatment.
- Question 5: In 2023/24, how many patients waited 8-12 weeks for treatment?
- Answer: Seven patients waited 8-12 weeks for treatment.
- Question 6: In 2023/4, how many patients waited 12-16 weeks for treatment?
- Answer: One patient waited 12-16 weeks for treatment.

#### Question 7: In 2023/24, how many patients waited 16-20 weeks for treatment?

Answer: Zero patients waited 16-20 weeks for treatment.

- Answer: Currently, there are thirteen children and adolescents on the waiting list for CAMHS eating disorder service.
- Question 13: In 2023/24, how many new referrals for CAMHS Eating Disorder Services were received?
- Answer: 384 referrals were received for CAMHS Eating Disorder Services in 2023/24.
- Question 14: In 2023/24, how many patients were readmitted to CAMHS Eating Disorder Services after being previously discharged?
- Answer: 63 unique patients were readmitted to CAMHS Eating Disorder Services. There was a total of 69 readmissions.
- Question 15: How many of these readmissions were of patients who were discharged less than a year ago?
- Answer: 51 of these readmissions were discharged less than a year ago.
- Question 16: How many of these readmissions were of patients who were discharged less than three years ago?
- Answer: 65 of these readmissions were discharged less than three years ago.

Question 17: How many of these readmissions were patients being admitted to CAMHS Eating Disorder Services for the third time?

Answer: Ten patients were readmitted for the third time.

Question 18: How many of these readmissions were patients being admitted to CAMHS Eating Disorder Services for the fourth time?

Answer: Two patients were readmitted for the fourth time.
