Answer: a. Hourly rates by grade:

b. Hourly rates by speciality

The Trust has reviewed question 1b of your request for information under the Freedom of Information Act (FOI) 2000.

Question 2: Please also provide the average and highest charge rate for locum doctors, by grade and specialty over the same period.


