Question 3: How many Asbestos Containing Materials (ACMs) do you have? If you

are uncertain, please provide an estimate.

Answer: The Trust has 156 ACMs.

Question 4: What format of asbestos register do you have? (e.g. paper based, Excel,

internal database, externally digital, asbestos consultant system, survey

reports etc.)

Answer: Internal electronic database

Question 5: Does your Trust have a dedicated person(s) to manage asbestos? If so

how many roles.

Answer: No.

Question 6: What is the job title of the person (or persons) who are responsible for

managing asbestos day to day (not the Dutyholder)?

Answer: Assistant Director of Estates – Engineering & Infrastructure.

responsibilities?

Answer: There is no dedicated person covering asbestos, so they also have other

responsibilities.

The information you have requested relates to less than five individuals and has the potential for those individuals to be identified. The Trust is therefore


unable to provide this information in detail.
