Their TAP project (Team around the Practice) in Camden builds on this tradition and incorporates Social prescribing, in partnership with the VSO -Mind in Camden". These services are amongst a number of pioneering approaches from throughout the UK, to be showcased at the MUS summit, all bringing new models, health economics data, outcome monitoring and patient involvement.
